With partnering with the town and renting a space at Town Hall and using our address BAON enterprises grant writers will be able to apply for USDA grants to help the town. Town Administrator Manning is working on a contract with BAON Enterprises.

Sludge Bed project: The popcorn asphalt needs to be repaired and the exhaust pipe also needs to be replaced too. We had three bids come in for the project, Town Administrator Manning went over the three bids and the cost, Council Starkey entered a motion and second was entered by Council Manning, a vote of 3-0 entered for the bid. Bid goes to Getaway; the sludge bed will be repaired in the spring.

It was also brought up that the tractor is too heavy to clean the sludge bed after it is repaired, Council Starkey entered a motion and second was entered by Council Manning, vote of 3-0 entered to assign the task back to Susquehanna to clean the sludge bed. The town is also looking into a bobcat with a front-end loader for the sludge bed.

Board of Appeals Attorney: Town Administrator Manning is writing a letter to Attorney's to Kent and Queen Anne's County looking for a new Board of Appeals.

Public trash cans: There is a lot of trash at the corner of Crane and Cypress Street where there is a bus stop, Town Administrator Manning would like to put a public trash can there. Town Administrator Manning is looking into the cost and how to anchor it.

QAC- "Shooting Club" amendment – Town Administrator Manning is going to draft a letter of Support and have the Council review it and see if they want to sign it.
