Resolution 2022-02 approval of bond issuance for the Fire Company was tabled due to no representative from Fire Company and changes in the amount of bond.

Administrator Manning reviewed quotes for flooring and hvac renovations to town hall from KRM. A motion was made by Council Starkey and seconded by Council Holland, a vote 4-0 was entered to removal and replacement of floors. A motion was made by Council Holland and second by Council Starkey, a vote 4-0 was entered for upgrade and replacement of the hvac system. We are working with Jay Silcox to provide a set of plans for the building to be used as we solicit for electrical repairs.

The Budget and a revised fee schedule were submitted for review to the Council. The Council reviewed information regarding Impact Fees, consideration needs to be made with regards to when to charge, the size of the home, and how to address the impact and needs of the fire company.
